

## OFFICIAL RULES

### Pheasants Forever Rooster Road Trip Giveaway

These Official Rules (“Rules”) apply to the Pheasants Forever Rooster Road Trip Giveaway (“Giveaway”) conducted by Pheasants Forever, Inc., 1783 Buerkle Circle, St. Paul, MN 55110 (“Sponsor”). By entering, you agree to be bound by these Rules. NO PURCHASE NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. SEE ENTRY SECTION FOR DETAILS.

1 PRIZE. One (1) grand prize for the Browning Citori 825 Field Over & Under giveaway will be awarded and will consist of one (1) Browning Citori 825 Field 12 Gauge Over & Under. Suggested retail price is \$3,149.99 without any warranty provided from the Sponsor or Browning Firearms.

2 DRAWING/ODDS OF WINNING a Browning Citori 825 Field shotgun. One (1) winner will be selected for the one (1) Browning shotgun in a random drawing from all eligible entries received. The drawing will be held on or about December 20<sup>th</sup>, 2024. Odds of winning depend on total number of eligible entries received.

3 GIVEAWAY PERIOD for Browning Citori shotgun. The Rooster Road Trip Giveaway begins November 11<sup>th</sup>, 2024 12:00 a.m. CST and ends December 16<sup>th</sup>, 2024, 11:59 p.m. CST (“Giveaway Period”).

4 ENTRY. There are three (3) methods to enter the Giveaway: (1) Join, renew, extend, or gift a Pheasants Forever or Quail Forever “Bird & Buck” membership during the Giveaway Period. (2) Become a Pheasants Forever or Quail Forever Life Member via the “YETI TUNDRA” promotion. (3) Alternate Method of Participation: You are not required to purchase a membership in order to participate in the Giveaway or win a prize. In order to enter without purchase, please print your full name and complete address with zip code on a 3” x 5” postcard and mail it in an envelope to: Pheasants Forever Rooster Road Trip Giveaway, 1783 Buerkle Circle, St. Paul, MN 55110. No copies or mechanical reproductions of 3” x 5” postcards will be accepted. The following categories of

persons are not eligible to enter or win: employees, agents and officers of Pheasants Forever, Inc., Quail Forever, and their respective parent companies, its subsidiaries and affiliates or any entity involved in the development, production, implementation and distribution of the Giveaway, including any advertising or promotion agency, supplier of prizes for the Giveaway, parent company, service provider, subsidiary, sales representatives, or affiliate of any such entity or any other entity directly associated with the Giveaway or any member of the immediate families (parents, children, siblings, spouse regardless of where they live) and those living in the same household (whether related or not) as such individuals. 6 MISCELLANEOUS. Winners will be notified by US Mail, and will be required to sign and return an affidavit of eligibility and liability/publicity release within fourteen (14) days of notification. Sponsor may select an alternate winner if winner fails respond within timeframe specified or if winner fails to meet all eligibility requirements set forth herein. By participating, entrants agree to release and hold harmless Pheasants Forever, Inc., and Quail Forever, their respective parent companies, affiliates and subsidiaries, and the officers, directors, agents and employees of any of the above entities from any and all liability, loss or damage to person (including death), property or reputation incurred in connection with their participation in the Giveaway and/or the receipt, acceptance, possession or use/misuse of the prize or their participation in any prize related activity.
